ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the Treatment Building for Well #10 Project will be received by Southington Water Department at the office of the Southington Water Department until 11:00 AM local time on September 3rd, 2024, at which time the Bids received will be publicly opened and read.

The Project consists of constructing a new well water treatment building, including installation of chemical feed systems, day tanks, bulk tanks, metering and transfer pumps, electrical supply and control equipment, new water delivery pipe system, instrumentation, driveway extension, and rehabilitation of existing driveway.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is: Southington Water Department, 605 West Queen Street, Southington, Connecticut 06489, and the contact person is Douglas Arndt. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 9am and 3pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below. Contract Documents will be available, physical copies or digital versions, through Advanced Reprographics, 50 Corporate Avenue, Plainville, Connecticut 06062, (860)410-1020, and through their website at advancedrepro.net. Bidders are responsible for all printing and shipping costs, as applicable.

A mandatory pre-bid conference will be held at 9:00 AM local time on August 20th, 2024 at the Southington Water Department, 605 West Queen Street, Southington, Connecticut 06489.

Bid security shall be furnished in accordance with the Instructions to Bidders.

If Owner awards the contract for the work, such award shall be to the responsible bidder submitting the lowest responsive bid. The Owner reserves the right to waive any informalities in bids and to reject any or all bids.

Contractors bidding for this project shall hold a current Prequalification Certificate for a designated classification from the Department of Administrative Services and a copy of the contractor's DAS Prequalification Certificate and Update (Bid) Statement must be submitted with their bid. Any subcontractor whose subcontract exceeds \$500,000 may perform installation or construction work as a subcontractor on a project, provided that at the time of the bid submission, the subcontractor is prequalified by DAS in accordance with CGS Section 4a-100.

All bids for this project are subject to the State of Connecticut prevailing wage rates. All applicable Federal prevailing wage rates and applicable Federal labor standards shall also apply pursuant to the Davis-Bacon Act. When both State and Federal wage rates are applicable, the higher rate must be paid.

Any contract or contracts awarded under this invitation for bids are expected to be funded in part by a loan from the State of Connecticut Drinking Water State Revolving Fund. Neither the State of Connecticut nor any of its Departments, agencies, or employees is or will be a party to this invitation for bids or any resulting contract.

Any contract or contracts awarded under this invitation for bids are subject to meeting subcontracting Minority and Women's Business Enterprise (MBE/WBE) goal conditions.

Any contract or contracts awarded under this invitation for bids are subject to the Use of American Iron and Steel (AIS) requirements.
